Responses to admissions consultation process December 2021 and January 2022. Consultation closed 31.01.2022

In total 344 emails were sent to all Notts CC schools, local MATs, neighbouring local authorities, local Diocesan offices, local playgroups/pre-schools and childminders where known. In addition, emails were sent to all trustees and governors and all Business Leaders and Executive Leaders, Executive Principals and Principals. All academies sent a message to parents via WeDuc. The consultation was also placed on social media sites by the Marketing and Communications Team and it featured as a pop-up on the Trust and all academy websites throughout the consultation period.

We received the following responses. 4 were via the MS Form we asked interested people to complete and the Notts CC letter was received via the email inbox that had been specifically created for any correspondence if responders preferred this method of communication.

This has been amended to read 'regardless of role'. The policy states that a letter from HR will be required to confirm that a member of staff meets the criteria. Now updated to read that HR must confirm if a member of staff has been appointed to fill a demonstrable skills shortage. |

Bracken Lane, Thrumpton, etc are on bus routes to Tuxford. Would this not be beneficial for our Trust as we have a clear link through with curriculum, pupil information etc, which is sometimes difficult to get hold of from other primaries | Each school has a defined catchment area on the Notts CC website and individual academies (including Tuxford) have historically consulted upon other feeder schools linking to a secondary.
